SIBA Testing Service, (STS) Sukkur IBA, University, Airport Road, Sukkur.**
2. Only eligible candidates fulfilling above criteria for post will be called for written test/skill test and interviews.
3. The list of eligible candidates and who pass the tests would be kept on IBA Sukkur's website ([www.iba\\_suk.edu.pk](http://www.iba_suk.edu.pk)).
4. The candidates those who have applied for the posts of Assistant BPS-16, Stenographer BPS-15, Data Processing Assistant BPS-12, Accountant BPS-11, Reader BPS-10, are informed that their initial test would be conducted by SIBA Testing Service, (STS) Sukkur IBA, University.
