

Frequently Asked Questions

Graduation

1. Graduate can apply or not?

Answer: No, if you have graduation (Minimum 14 years of education in any discipline) along with B.Ed (Minimum 1 year or above) than you can apply. While the candidates having simple graduation are not eligible to apply.

2. Graduate with Continue B.Ed?

Answer: No, only those are illegible who have completed their B.Ed. Provisional slips or candidates appeared in B.Ed are not eligible.

3. Graduate & Just waiting for Result?

Answer: No, only those can apply who have completed their degree, result awaiting cannot apply. Waiting for result and provisional slips or candidates appeared are not eligible

4. What is Age Relaxation?

Answer: As per policy of Sindh Government 15 years is age relaxation, it means maximum age is 45 Years upto expiry of date to apply i.e. 20th April, 2018.

Online Application Submission

1. What will be the criteria for online form?

Answer: You can apply online after 26th March, 2018. Further, the guide lines are mentioned at www.sts.net.pk, at the end a challan form of Rs. 500/- will be generated online. Which contain deposit ID, and you have to print it & deposit it in any branch of ABL in Pakistan.

2. Shall we send hard copy of online printed form & challan?

Answer: No, you have to only upload all documents including challan for online apply visit our website www.sts.net.pk

3. Why you have given two dates?

Answer: March 26, 2018 date exhibit that you can apply online after that, while 20th April 2018 is last date to apply for both online as well as by sending documents through courier.

4. Website to apply online?

Answer: Visit www.sts.net.pk

5. What is the fee of Online apply & through courier documents?

Answer: For online apply Rs 500/- is the fee of challan. For manual apply/downloading the form and challan, after filling, send it to STS with challan fee of Rs 600/-.

6. Why there is difference in challan?

Answer: Because you fill your online application by own and attach relevant documents. Further, STS encourage to online apply that's why the relaxation of Rs. 100/- to online applicants.

7. Who can apply?

Answer: The candidate will have to apply against the vacant post at their relevant Taluka wise.

B.Ed (Effective upto 2020)

8. What do you meant by (effective up to 2020)

Answer: This line means, as per instruction from School Education & Literacy Department, Govt: of Sindh those candidate who have competed their 1 year B.Ed, after 2020. The 1 year B.Ed will expire as per policy. This line did not mean you can apply & complete your B.Ed or other diploma within 2020.

Test Criteria and Test Centers

1. What is test Criteria?

Answer: The test criteria will be uploaded on STS & Sukkur IBA University Website: www.iba-suk.edu.pk and www.sts.net.pk

2. What will be the test Center?

Answer: The test will be conducted at divisional headquarter (subject to availability of sufficient number of candidates) of Sindh Province.

ECE Diploma

1. For ECT position, those female candidates who have still not done the ECE/ Montessori diploma, are they Eligible to apply?

Answer: No, those candidates who have completed ECE/ Montessori diploma from STEDA accredited board/ institute/college are also eligible to apply.

2. What do you mean by ECE/ Montessori diploma?

Answer: The duration of diploma means minimum 1 year.
